Fees related issue for existing students

In terms of the direction of the Division Bench of the Hon'ble High Court at Calcutta in WPA No. 5890 of 2020 dated October 13, 2020, and in particular para 61 of such order, the following intimation is being given to the parents/guardians:

1. Parents and guardians of students are offered the option of paying fees as per clause 3 and 4 below.

Parents are requested not to avail of the reduction in fees as prescribed in Clauses 4 if their financial situation does not merit such reduction.

- 2. Parents/guardians who have paid 100% of the tuition fees as on date of this intimation and/or intend to pay and/or continue paying 100% of such tuition fees and/or have paid 100% of the session fees and/or intend to pay 100% of session fees are requested to do so.
- 3. The 100% of applicable fees for the period 2020-21 to be paid on quarterly basis as indicated till such time as reopening of the school in physical mode are as follows.

In the event the parents who have paid 100% of tuition or session fees wish to avail of the reduction indicated in Clauses 4, they will not receive any refund but will have the balance in their favour adjusted against payment of tuition fees for the period subsequent to November 30, 2020. Request for such adjustment should be made on email as mentioned in clause 7.

- 9. ALL FEES FOR THE PERIOD UPTO 30th November 2020 IS TO BE PAID BY 30th November 2020 BY ALL STUDENTS/PARENTS. IF NOT FROM 8th December 2020 THE SCHOOL WILL HAVE THE OPTION TO DISALLOW THE STUDENT FROM ATTENDING SCHOOL ONLINE OR OTHERWISE IF FEES IS NOT PAID FOR THE PERIOD UPTO 30th November 2020.
- 10. No student will be entitled to apply for a transfer certificate without the full quantum of fees in terms of High Court order being first discharged.
